



# **TATTOO CONVENTION**

**Bärenhalle, 95463 Bindlach - 9th and 10th October 2021**

---

## **General terms of participation**

### **1. Registration:**

Registration for participation can only be done by submitting a completed, confirmed or signed registration form. Changes on the form are not valid. Submitting the registration form by signature is binding. The participant is willing to adhere to all regulations concerned. The contract is confirmed by writing and sending the bill to the participants, a legal entitlement to contract does not exist. With the signing of the declaration, the name/address of participant can be published. Additional agreements are only legally if these are available in written form and confirmed

### **2. Opening hours:**

Saturday, 9th October 2021, 11:00 h until 23:00 h and

Sunday, 10th October 2021, 11:00 h until 19:30 h.

### **3. Stand construction and stand removal:**

The participant is obliged to complete installation and removal in the specified time subject to prior agreement!

Construction: Friday, 8th October 2021 from 21:00 until 23:00 h  
Saturday, 9th October 2021 as of 08.00 h

Removal: Sunday, 10th October 2021 until 20:30 h

Removal during the convention is not permitted both for the public benefit and remaining exhibitors.

### **4. Terms of payment:**

The amount is payable net cash within 14 days with reference to invoice and date (plus VAT). Failure to receipt of the rental of the booth, the organizer can terminate the contract without prior notice. The stand fee is payable even if the participant will not attend the event. Claims of the participants in the events expire after 14 days after date of invoice.

### **5. Distribution of booth:**

Distribution of available space/booth is effected according to registration received. Modification in available space will be part of the contract. Compensation claims are excluded for both parties.

**Price for tables:** Tables for the booth can be rent against a fee of EUR 6,00 per table.

### **6. Liability:**

#### **6.1 Exhibitor**

The exhibitor is responsible for insuring all of his device, articles etc himself and for any damage caused by himself or by his assistants jointly.

#### **6.2 Organizer:**

The organizer accepts no liability for damages and consequently damages tot he exhibits and booth equipment.

### **7. Exhibitor pass:**

Each stand receives a certain number of exhibitor bracelets which must be carried along by the participants during the event. Those coloured bracelets are neither transferable nor salable. They authorize the exhibitor for

entrance in hall and VIP lounge.

**8. Photos, films:**

Commercial photography and filming on the event area is allowed only from person authorized by the organizer. The organizer has the right to take pictures and movies without further consent to the use of images, sound and movies that were created at the event by authorized persons.

**9. Guard / Security service:**

The general guards of the area and hall is the function of the organizer without liability for loss and damage. For the supervision and guard of the booth, the exhibitor is personally responsible. This also applies to the construction and removal times, outside the opening times

**10. Domiciliary right:**

The organizer has the "domiciliary right" on the entire area and hall during the event.

**11. Severability clause**

In case any provision of the above conditions and terms will be invalid, the validity of the remaining provisions will not be affected.

**12. Hygiene**

One printed copy of hygiene requirements (available for download on our homepage) must be brought along by the participant and must be strictly adhered!

Important: It is not permitted to effect any tattooing and/or piercing works on tables or chairs without any hygiene cover!

**13. Miscellaneous:**

Sale and/or service of food and drinks is prohibited.

Open fire in the hall is prohibited

Access and escape routes must not be blocked

Hall floor must not be contaminated

Waste and leavings must be thrown into corresponding baskets

For property damage, personal injury, the organizer shall not be liable

Pricing according to the law must be provided

Posters etc. to be fixed at the hall wall are not allowed.

Advertising is permitted only after prior approval by the organizer

Electricity 220V per booth is available; connectors are not provided

For piercing works, the minimum price is EUR 20,00 (without piercing deco).

For tattooing works, the minimum price is EUR 40,00.

During the event, smoking is strictly prohibited in the hall; smoking areas are designated outside the hall

Instructions of security service must be complied

Parking space for tattoo and piercing artists available behind Bärenhalle (Sportplatz)
